For the eight (8) calendar years immediately following the holding of the referendum, shall the South Bend Community School Corporation, St. Joseph County, Indiana, impose a property tax rate that does not exceed thirty-three and thirty-four one hundredths cents (\$0.3334) on each one hundred dollars (\$100) of assessed valuation and that is in addition to all other property taxes imposed by the school corporation for the purpose of providing funding for (a) the maintenance, enhancement, and expansion of curriculum and course offerings, (b) the creation of additional opportunities for career pathways including trades and career center course offerings, (c) increases in teacher compensation, and (d) comprehensive behavioral and emotional supports for students with counselors, college coaches and social workers in each building?
