NOTICE is hereby given the Board of Commissioners of St. Joseph County, Indiana will publicly open and read aloud bids on **Tuesday, June 14, 2022**, hour of ten o'clock [10:00] a.m. [E.D.T.] in the County Council Chambers, Fourth Floor, County-City Building, South Bend, Indiana, as per Specifications on file, beginning May 27, 2022, on the County web-site available at <http://www.sjcindiana.com/Bids.aspx> for the following Project:

R&S 92201 D: COMMUNITY CROSSINGS MATCHING GRANT MAINTENANCE ASPHALT OVERLAY

The project entails roadway milling, salvaging roadway material for sub-base, HMA base, intermediate and surface courses, removing trees, replacing culverts, repairing drainage structures, placing shoulder, and pavement markings at various sites. Estimated Project Length = approx. 10.9 miles.

SAID bids must be accompanied with a Certified Check made payable to St. Joseph County or Bid Bond executed by the bidder and surety company in a sum of not less than ten percent [10%] of the total amount of the bid, together with a non-collusive affidavit as prescribed in Form 96, Revised 2013. The bidder awarded the contract will be required to furnish separate Payment, Performance, and Maintenance Bonds before commencing work. The Payment and Performance Bond shall each remain in effect throughout the entire construction period in an amount equal to the awarded Contract Amount. The required Maintenance Bond shall remain in effect for a period of up to five years from the date of final acceptance in an amount of 10 percent [10%] of the awarded Contract Amount. The bidder's attention is directed to the Affirmative Action Requirements and the Insurance Provisions of the Project.

**AMENDMENT TO AGREEMENT FOR LIMITED LEAF COLLECTION & DISPOSAL SERVICES -
SUBSCRIBER SUBSIDY PROGRAM**

The undersigned parties executed an Agreement for Limited Leaf Collection & Disposal Services - Subscriber Subsidy Program (the "Agreement") effective April 27, 2021. The parties now desire to amend this Agreement (this "Amendment").

In the event of any conflict or inconsistency between the provisions of this Amendment and the Agreement with respect to the terms hereunder, the terms of this Amendment will take precedence.

NOW, THEREFORE, in consideration of the promises, the covenants and agreements hereinafter contained, and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, St. Joseph County, Indiana ("SJC") and St. Joe County Recycling, L.L.C. ("SJCR") agree as follows:

AMENDMENT 1

Term shall read as follows:

The Term of this Contract shall be for the period beginning as specified above and expiring on August 30th, 2027.

AMENDMENT 2

Amended Item 6(b) Shall be removed in its entirety and replaced with the following:

(b) Wheel Loader – SJC shall provide SJCR use of its Six-Cubic-Yard Wheel Loader – CAT 972G at all times, with SJCR providing its own operator. SJC will rent a 6cyd wheel loader as needed if SJC wheel loader is unavailable at any time. SJC shall pay SJCR per rate sheet to transport as needed if SJC transport is unavailable.

If, during the Term of this Contract, SJC determines that its Six-Cubic-Yard Wheel Loader – CAT 972G is surplus, SJCR shall have the right of first refusal to purchase it. The purchase price shall be the average of 2 valuations obtained by SJC. After the completion of such purchase to SJCR, SJC shall have no further obligation to provide a wheel loader for SJCR's use.

Amended Item 6 shall add as follows:

(f) Tip Sites – No County Garage Properties may be used as a tip site. SJC shall not be required to compensate SJCR for SJCR's procurement or use of another property for a tip site.

(g) SJC Operators – Notwithstanding anything to the contrary herein, SJC shall not be required to provide any operators to assist in operations or compensate SCJR for any operators they may hire.

AMENDMENT 3

Amended Item 11 shall add as follows:

Public Education & Outreach – Direct mail printing and postage shall be paid by SJC up to \$ 15,000.00 upon submittal.

AMENDMENT 4

Amended Item 26 shall add as follows:

Fuel – SJCR may fuel at SJC garage sites, but they may not park or stage any vehicles, equipment, or supplies etc. on any County Garage Property. Once fueling is completed, SJCR must remove its property from the Garage Properties.

AMENDMENT 5

Amended Item 49 shall be amended as follows:

Renewal Option – “Three” shall be changed to “Five”. “December 15, 2023” shall be changed to “December 15, 2026” and “December 15, 2026” shall be changed to “December 15, 2029”.

AMENDMENT 6

Attachment A shall add as follows:
